



Saxonburg Area Baseball Association (SABA) is required by Pennsylvania law to clear all volunteers through three separate background check processes. Any Volunteer that has direct contact with Children must complete the background procedure, this includes but is not limited to all Coaches and Board Members. No one will be permitted on the Fields or in the dugouts without the proper documentation on file. Access to background check information is kept confidential and made available to Board Members on a need to know basis.

You must submit this form and copies of the below applicable certifications before you will be permitted to volunteer.

**1. PA State Police Certification**

**2. PA Child Abuse History Certification**

(There is no cost for volunteers. Print response certificate.)

**3. (Check box that applies below)**

*\*All volunteers are required to update their certificates every 60 months.*

*\*\* If a volunteer is arrested for or convicted of an offense that would constitute grounds for denying participation in a program, activity or service, or is named as a perpetrator in a founded or indicated report, the volunteer must provide the SABA Board with written notice no later than 72 hours after the arrest, conviction or notification that the person has been listed as a perpetrator in the statewide database.*

*\*\*\*A volunteer who willfully fails to disclose information as required above commits a misdemeanor of the third degree and shall be subject to discipline up to and including termination or denial of a volunteer position.*
